

## PRIVACY STATEMENT

- This statement sets out the privacy policy of PelicanCorp (UK) Limited, a company registered in England and Wales whose registered office is at CO/EBS, PO Box 3942, Innovation Centre, Gallows Hill, Warwick, CV34 9AE, England (registered with number 06597822) ("we", "us" or "our") in relation to the holding and using of information, which we may obtain from you when you contact us via <u>www.beforeudig.ie</u> (the "Site").
- 2. If you have opted to provide us with personal information about you and you are a registered user of this Site, we may, in addition to using it to process any enquiry placed by you, use this information to contact you by email telephone or post to provide you with details about other information which we believe may be of interest to you, including, without limitation, advising of new products and services available on the Site and any directly linked website operated by any of the beforeUdig Members.
- 3. You may tell us on the web page where you input your personal information if you do not want us to use your information for these additional purposes. You can also tell us at any time to stop using your information for these additional purposes by emailing <u>contactus@beforeudig.ie</u>
- 4. You will be required to enter certain information about yourself in order to access the information held on this beforeUdig web Site. This information is held by us for use in the following circumstances:

- 6. This Site incorporates the use of Cookies. Cookies are small data packets that are sent from a server computer during a browsing session. Cookies are stored for the length of the session. If your browser options allow you to disable cookies, and these are set, you will not be able to use this site. The cookies used for this session do not store any personal information.
